Attorney General attends Law and Justice Conferences in Australia.

Cabinet had approved the travel of the Attorney General, Susuga Aumua Ming Leung Wai, to participate in the 3rd Pacific Regional Law and Justice Conference in Brisbane from the 31 July – 2 August, 2007, as well as the International Criminal Court Regional Advocacy Seminar in Canberra on the 6th August, 2007.

The 3rd Pacific Regional Law and Justice Conference facilitates robust policy debate and strengthens understanding of how to support law and justice sector in the Pacific and improve implementation towards integrated approaches as mandated in the White Paper on Australian Aid. Additionally, the ICC Advocacy Seminar will discuss overview of the ICC work to date and benefits of ICC accession for Pacific Island countries. The Attorney General will deliver a speech

on Samoa's experience in passing domestic legislation and how it addressed domestic concerns.

Susuga Aumua Ming Leung Wai is the current Chairperson of the Law and Justice Sector Taskforce and a lawyer in the International Criminal Court.
